

**Terms & conditions of the Birthday 2022 Offer
(hereinafter: 'Terms & Conditions')**

THE RESPONSIBLE ENTITY

These Terms and Conditions have been issued by PayU S.A. with registered office in Poznań (60-166) at ul. Grunwaldzka 186, entered in the Register of Entrepreneurs kept by the District Court in Poznań – Nowe Miasto i Wilda in Poznań, 8th Commercial Division of the National Court Register, under National Court Register (KRS) number 0000274399, having Tax Identification Number (NIP): 7792308495 and Statistical Number (REGON): 300523444, fully-paid share capital in the amount of PLN 6.474.300,00 PLN, hereinafter referred to as '**PayU**'.

SCOPE

These Terms and Conditions determine when and how PayU may reduce the fees payable under the Merchant Agreement ("**Agreement**"). The current content of the Agreement is available on the website: <https://poland.payu.com/en/documents-to-download/>

Merchant means a party to the Agreement with PayU. A Merchant can be an adult natural person running a business, a legal person or an organizational unit without legal personality, which is granted legal capacity by the law

CONDITIONS OF THE BIRTHDAY 2022 OFFER

1. The Birthday 2022 Offer is valid for the Merchants who meet the criteria specified below and consists in a reduction of certain fees payable to PayU:
 - a) the activation fee is PLN 20,00
 - b) during the first three months of cooperation with PayU, the fee per each Transaction in PLN is 1.2% of the Transaction value and additionally PLN 0,30 for payments made with a payment card.
2. If the Merchant does not meet the criteria below, PayU will charge the Merchant's Settlement Account with a non-refundable fee of PLN 179 by deducting it from the amounts of Transactions due to the Merchant. This amount is the difference between the reduced activation fee and the standard fee in PayU's price list, i.e. PLN 199.
3. In matters not regulated in these Terms and Conditions, the provisions of the Agreement and the generally applicable provisions of law shall apply.
4. The Birthday 2022 Offer is valid from September 19, 2022.

RULES OF USING THE BIRTHDAY 2022 OFFER

The 2022 Offer applies only to the Merchants who enter into the Agreement with PayU for the first time and fulfill all the following criteria:

- a) they register by submitting an application to use the services of the PayU System via the website available at:

and will pay the activation fee within one month after registration.
For Merchants who registered prior to the Birthday 2022 Offer but did not pay the activation fee yet: send a message to operations@payu.pl, accept the Agreement available in the Merchant Panel (Manager Panel) and pay the activation fee within a month after accepting the Agreement;
- b) have accepted at least one Transaction on the Website executed through any payment type-except "test payment"-among the ones described on the following website:

- c) have successfully passed verification with PayU, carried out in accordance with the Agreement.
